- Equity component? There’s a place for this in the assignments (like case study of historical events in law enforcement; current events; consideration of BIPOC folks and their perspectives. Taking into account some time for reflection.)
\* Textbook dates (per Erick) – How about some newer texts, ones that speak to the current events / changing policing. Noticed some 2011 & 2017 textbooks.
> In search of something meaningful, not just the “flavor of the day.” Likes some mainstream and some “challenge the mainstream” texts. 2011 text is a great one! Balance between fresh perspective & things that’ve been time-tested.
- Making sure it’s in line w/ what we’re doing and what we want to do.
