Senate Bill 478 (Portantino) 2017 

Senate Bill 478 would require California Community Colleges to identify students who have completed all requirements for the Associate Degree for Transfer (ADT), notify these students of their completion of ADT requirements, and automatically award qualified students with the ADT degree unless the student affirmatively opts out of being included.

Title 5, Section 55063
Minimum Requirements for Associate Degree



The governing board of a community college district shall confer the associate degree upon a student who has demonstrated competence in reading, in written expression, and in mathematics, and who has satisfactorily completed at least 60 semester units or 90 quarter units of degree-applicable credit course work as defined in section 55002(a) which falls into the categories described in section 55062. A college may also accept toward satisfaction of this requirement courses that were not completed at a California community college that would reasonably be expected to meet or exceed the standards of section 55002(a).

Title 5, Section 55072

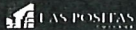


The governing board, or its designee, shall award the appropriate certificate to any student who has completed the prescribed curriculum leading to that certificate as approved pursuant to Title 5, Section 55072

State Funding Formula

A new funding formula that focuses on rewarding equity and success rather than fully focused on student enrollment, is vital in guiding California Community Colleges in realizing their mission. The latest information:

- 70% Base Allocation
- 20% Supplemental Allocation
- 10% Degree Completion




