## 3. Review and Approval of 9/28/20 Minutes

Motion, William Garcia Second, Todd Steffan Motion passed with note to update Item 5 to include, as part of the Architectural Barriers project, Admission and Records, Counseling, Financial Aid, and the Information Desk departments met to discuss next steps

#### 4. New Business

- 2020 Space Inventory
- o Zahra who works at the District Office and is one of the District Facilities meeting Tri-Chairs joined the committee to discuss LPC's Space Inventory report
- o The inventory report which is due November 2, 2020 is required by the State Chancellor's Office.
- o The report provides details on the age of the building, its square feet, assignable square feet, number of stations, and usage of the rooms
- o The usage elements allow for sorting by room type i.e. lecture hall, lab, offices, etc.
- o The State determines their capacity to load based on the report
- o Ratios in excess of 100% indicate efficiency of space
- Anything under 100% equates a deficiency
- The library is at 93% and other AV/TV is 32%
- o Offices, lecture, and labs are all above 100%
- o There were no changes between the 2019 & 2020 reports
- In September 2020 the Board of Governors(BOG) approved changes to Community College lecture and office spaces project scoring metrics standards
- It will impact the Capital Outlay program priority and grant application process to the Space Utilization and Space Standard which was updated in 2010
- o The changes provide flexibility to serve students & improve student access, aligning standards with the Division of State Architects (DSA) and CA Fire Marshal Safety Code
- o The changes also increase an office room type by 25%, and lecture type by 33%
- There is now 20 assignable square feet per student

- The impact of changes will show in the next five-year capital alternative plans
- Assignable square feet for Faculty include the space for an Admin, Dean and workspace is now 175 square feet
- Areas that rank under 100% are ranked higher for State funding
- Two points are assigned for every student increase
- Local Bond money historically drives every district over the 100% in the cap load ratio

## • Art on Campus Taskforce

- In 2007, LPC was awarded funds from the Nike Art Foundation to assist with placing art on campus in public spaces
- The Art of Campus committee was commissioned by College Council
- Art purchased from the funds include the Fletcher Benton sculpture outside of room 1726 and some decals placed in Building 2500
- Chair of the Task Force and Dean of the A&H, Amy Mattern, along with Peter Kuo, and Deanna Horvath shared a presentation of their proposed projects
- The focus of their work is acquiring art from local Bay Area artists, and LPC students
- One of the group's goals are to include cultural diversity in nature to engage multiple senses
- Since there is no marker on the Fletcher Benton piece, a plaque will be purchased as well as research into possible maintenance fees
- Equity and antiracism were identifying by the President's Task Force as a call to action to identify and display African American art on campus
- This is part of creating a culture of care and compassion as well as creating a welcoming campus for students and employees of color and specifically for African American and Black students
- The committee is working to acquire work from Bill Owens, a photographer who has completed a photo project in the Tri-Valley and has published a book called Suburbia
- Stephanie Guillen is another local resident the committee is looking into
- Retired LPC Art Faculty, Stephen Albair is another potential artist
- The committee will also identify locations for the art
- Bay Area muralist, Aaron De La Cruz was commissioned by the committee

- o Research on a final mural location is underway
- A website to capture all of the committee's work is forthcoming
- The committee also hopes to purchase student art work after their work is exhibited at the end of each semester
- The committee will continue to work in collaboration with the Dr. Foster and the President's Office
- The Bond program can pay for an instructional display but not for art or a beautification project
- o The balance in the Nike Art on Campus fund is \$189, 517

- o The space inventory report was shared
