Mr. Sbranti is an East Bay native with a unique background and experiences in education, public service, and athletics.



Assembly Speaker Anthony Rendon reappointed him in 2017, and he is the agency's longest-serving Board Member and current Vice-Chair. Other examples of Mr. Sbranti's statewide leadership in education include his work as the first Executive Director of the Californians Dedicated to Education Foundation, where he was chosen by former State Superintendent of Public Instruction Tom Torlakson to lead his statewide non-profit foundation to build the capacity of the California Department of Education. Mr. Sbranti also served on the California Teachers Association (CTA) State Council for nine years. 
