

# Missing Receipts

**Note:** this process must be followed PRIOR to submitting your relevant reimbursement, expense claim, etc.

Employee fills out Missing Receipt Statement Form

Submit to Dean for approval

Submit to District Vice Chancellor, Business Services for final approval

Fully approved form returned to employee

Attach fully approved form to relevant document (reimbursement, expense claim, etc.)

Submit document in accordance with its respective process
