EXPLANATION TO STUDENT: An education plan is required for all students who have attempted 30 units, including transferable units from previous colleges. Federal regulations require that receipt of financial aid is limited to 90 attempted units for associates degrees and/or transfer majors at a two year college. 'Attempted units' includes all units for which you have registered, whether a grade was earned or not, and includes courses from which you have withdrawn. You are highly encouraged to carefully follow your education plan so that you are able to complete your degree requirements within the allowable 90 attempted unit timeframe. Should you change your major, you should meet with a counselor to develop a new education plan to assist you.

Students may attempt up to 30 units of Basic Skills units and an unlimited number of ESL units in addition to the 90 attempted unit limit.
