4. Review of 2020-2021 Accreditation Work Teams

There has been some difficulty seeking a faculty lead. VP Whalen created a draft list of administrators, faculty, and classified professional team leads to work with teams on assigned standards. The committee discussed/reviewed the draft list and made suggestions. VP Whalen will contact/follow up with those on the list to confirm their participation.

Review of 2020-2021 Accreditation Work Plans & Timelines

Some comments made during the discussion:

- Meeting every other week might be too aggressive – not enough time to come up with answers.
- This is a draft; we'll use as a plan; we'll adjust the dates.
- Need feedback from whole committee – expand the window for response.
- Start writing vs. collect first, then write (individual preference)
- Standard interpretation needed, sooner rather than later, especially since there are so many new folks; then they can decide how they'd like to move forward (different thought processes); need to be able to read the standard well in order to answer the question.
- Give everyone a copy of the "Guide to Institutional Self-Evaluation" as reference
- At the beginning of fall, we could have a kick-off meeting with breakout rooms for all on the list (give them the guide, standards, and evidence collected to date; teams can identify and early problems they might see.
- Interpretation, draft around the evidence, gap analysis. Give team both options and let them decide.
- Date and time of "kick-off" event to be determined
- 1A and 1B folks are the same folks, so maybe time should be staggered (1B should start after 1A ends)
