



District-wide Information Technology Building

The Division of State Architect (DSA) issued the permit approval June 2, 2008. The construction management team is finalizing the bid schedule, coordinating construction activities on this project with those of the Maintenance & Operations Facility, Central Plant and new Parking Lot H and campus operations.

Parking Lot H & Solar PV System

The design of the new Lot H received DSA permit approval on June 11, 2008. The solar panels and structures were submitted to DSA separately and are now under review. The construction contract for the parking lot portion of the project (in addition to the shade structures and solar equipment) has been awarded. Notice to Proceed (NTP) for construction was issued June 23, 2008. Chevron is working to have the parking lot ready for use in the Fall Semester (August 18, 2008). Installation of base rock and curbs are underway. All work is scheduled to be completed by May 31, 2009.

PE Phase III

The user-group met with the Design Team to provide their comments on the 90% construction documents. Document submittal to DSA for permit review is planned for September 2008.

Campus Boulevard Phase I

The Design team redesigned a simplified project due to the original design being estimated at 100% over budget. The new design was presented to the User Group in April, 2008. Input provided at that meeting has been incorporated and is now under review. Upon approval, construction documents will be completed.

College Center for the Arts

The Board of Trustees authorized award of a construction contract at their July 15, 2008 meeting. Notice to Proceed for construction was issued on July 30, 2008. Work is underway, with significant truck traffic between the project site and the area outside the Loop Road as "spoils" from site excavation activities are transported off-site.

PE Complex & Multi-Disciplinary Building

District staff and legal counsel met with representatives of the parent company of the General Contractor June 17, 2008 who committed to correcting all defective work. The General Contractor will review the forensic architect's reports with their subcontractors and submit a proposed work-plan. It is recommended that detailed design of the remediation work commence to expedite the repair process. Design of temporary mitigation measures is currently underway.

Central Utility Plant

The Design Build Contractor, Southland Industries, is working on detailed design for the Central Plant. Southland mobilized and commenced work on the utility loop in April, 2008. The first phase of utility loop trenching was completed on schedule. The second phase is well underway and work is progressing per schedule.

Maintenance & Operations Facility

The Board of Trustees authorized award of a construction contract at their July 15, 2008 meeting. Notice to Proceed with construction was issued on July 25, 2008. Work is underway.

Child Development Center

The Division of State Architect (DSA) issued the permit approval June 2, 2008. The construction management team is finalizing the bid schedule, coordinating construction activities on this project with those of the Maintenance & Operations Facility, Central Plant and new Parking Lot H and campus operations.

Aquatics Center & Soccer Field

The playing field portion of the Soccer Field construction was completed as planned, with the District taking beneficial occupancy on June 16, 2008. Areas surrounding the Soccer Field, however, will remain under construction through August 2008. At the Aquatics Center, the Pool House shell has been completed. Roofing and interior wall construction is underway. Both the competition pool and the smaller swimming pool have been excavated and rebar installed. Application of the concrete liner is currently in progress. The entire project including the Aquatics Center and remaining work at the multi-use field is scheduled to be completed in November 2008, with occupancy and use the following month.

Student Services/ Administration Building

At their April 15, 2008 meeting the Board of Trustees authorized exploration of the Design Build (DB) delivery method to determine if it is appropriate to meet the goals of the project. Due to the unique challenges associated with this project site and the complexity of the program, the District is considering utilizing the DB delivery method to design and construct the project. Under this project delivery method, the District would conduct a prequalification process and short-list three teams consisting of Architects partnered with General Contractors which would submit conceptual design proposals. One of the three teams submitting proposals would be selected using a best-value selection criteria. A review of the project is underway to confirm whether the DB delivery method is the best delivery method to meet the goals of the project. A recommendation will be submitted in July.
