College Center for the Arts The bid date was postponed from May I to May 29 to accommodate bidders' requests for additional time to compile competitive and accurate bids. On May 29, 2008 four contractors submitted bids which were within 4% of each other, indicating competition and reliable pricing. A recommendation has been submitted to the Board of Trustees to award a construction contract at their meeting July 15, 2008.

Student Services/Administration Bldg.

At their April 15, 2008 meeting the Board of Trustees authorized District Staff to utilize the Design Build (DB) delivery method if it is deemed appropriate to meet the goals of the project. Due to the unique challenges associated with this project site and the complexity of the program, the District is considering utilizing the (DB) Delivery Method to design and construct the project. Under this project delivery method the District would conduct a pre-qualification process and three teams consisting of Architects partnered with General Contractors would submit conceptual designs. One of the three teams submitting proposals would be selected via a shared governance selection process. Staff are working to determine if the DB delivery method will provide best value to the District, and will submit a recommendation some time in July.

Campus Boulevard Phase I

The Design team has developed a simplified design because the original design was estimated at 50% over budget. The new design was presented to the User Group in April. Input was provided to the Architect for incorporation to the design. The Architect is currently awaiting direction to proceed with finalizing the design. The District may consider further re-design to incorporate future facilities in the area, such as the Student Services Administration (SSA) facility.

Parking Lot H & Solar PV System The design of the new parking lot received DSA approval on 6/11/08. The Shade Structures and Solar panels, wiring, and components have been submitted to DSA separately. DSA approval is pending. Chevron has awarded a construction contract for the parking lot portion of the project (less the shade structures and solar equipment). Notice to Proceed (NTP) with construction is expected by the first week in July. Chevron is working to have the parking lot useable by the start of fall Semester (8/20/08). The construction of the shade structures at the new parking lot areas will begin several weeks later, when the number of cars on campus has reduced through attrition. At that time, half of new parking lot "H" will be closed for the shade structure construction. The other have will begin after completion of the first.

Aquatics Center & Soccer Field

The Construction Contractor was issued the Notice to Proceed 11/5/07. Since that time work has proceeded smoothly, excepting approximately two months when rains slowed much of the earthwork activities. The Soccer Field subsurface and drainage system, and artificial turf material installation have been completed. The field lighting poles and fixtures have been installed. The electrical system for the field lighting was energized on 6/13/08. The play field portion of the Soccer Field construction was completed as planned, with the District taking beneficial occupancy by 6/16/08. Areas surrounding the Soccer Field, however, will remain under construction until 8/08. The Aquatics Center construction, until recently, has focused on the construction of the Pool House. Foundations, utilities, ground and second floor slabs, and masonry walls up to the roof level, have been completed. This period excavation for the two swimming pools was completed, with rebar installations currently underway in preparation for the concrete pool lining. The Aquatics Center portion of the project is scheduled to be complete 11/08.
