BAM Timeline

- Chabot counterparts prefer to view the proposal from VC Nicholas and modify it as needed during the PBC meeting
- The model currently favors one College over the other in terms of funding
- LPC does not agree with the proposed model as it puts the College at a deficit
- At a DEMC meeting, the conversation revolved around a movement to the new BAM and the 3A allocations for nursing and dental hygiene; Chabot does not want to lose the allocation until the final move to the SCFF model
- The committee agreed that changes on the DEMC and budget sides should occur concurrently
- The committee went into the yearlong discussions in good faith, breaking down the allocation model with a best-fit agreement for the District overall
- The consensus was that the early introduction of the model might lead to difficult discussions at DEMC and PBC about money
- At the November Board meeting, a budget date is expected with the tri-chairs providing the presenation
- The committee believes transparency is key when working on setting a funding formula
