We are unable to offer courses in Music Technology or the certificate without acquisition of this necessary equipment.

SECTION 7: TOTAL COST OF OWNERSHIP (FINANCIAL & SUSTAINABILITY

What is the potential life span of the requested equipment?

Recommended by our I.T. department, these specific iMac computers offer specifications designed to last 4-5 years, potentially longer. At that time the requirements of the Music Technology program will be re-evaluated and weighed against the capability of the current hardware/software. The Wenger Class Piano Workstations will never need to be replaced.

If new storage is needed, describe the storage, location, and costs: (Specific storage costs should be detailed in the "Part A: Initial Start-up Costs" section below.)

Our keyboard lab requires workstation/desks that sit on top of each Clavinova piano (sold by Wenger Corp.). They are permanent fixtures that allow each computer workstation to be secured safely, to prevent theft or mis-use. The lab already has 6 workstation/desks, requiring the acquisition of 14 more. We recieved a one-time-only huge discount of \$111 per unit for this purchase only. The total would be \$9,988.18 instead of \$11,753 (which is already discounted %10)

What will be required to maintain the equipment, such as regular servicing or upkeep? (Specific on-going costs should be detailed in the "Part B: On-Going Annual Operating Costs" sections below as applicable.)

Maintenance will be monitored and handled by our LPC tech support, so there are no additional costs. Software will be updated as required, sometimes requiring one-time upgrade fees on a per-workstation basis. No maintenance is need on the Wenger workstations once they are installed.

Explain how this equipment meets or exceeds basic sustainability efforts and/or provides renewable resources to the college:

Simply, these machines were selected specifically to meet sustainability efforts for our campus. Opting for lower-level technology will require an earlier replacement/upgrade date. Modern technology evolves at an extremely fast pace; Acquiring the best computer equipment possible will offer the longest period of functionality.
