The Communication Studies program is designed to provide students with fundamental understanding of the principles of speech communication as well as experience in the application of these principles. Participation in these classes develops critical thinking, personal growth, research, presentation skills, and an understanding of diversity. Classes prepare students for transfer to four-year institutions and entry into careers in which effective communication skills are important, such as teaching, public relations, and law. In addition, the department houses the forensics speech and debate team. The team travels to statewide, national and international tournaments. Currently, the CMST department has three full time faculty members in the discipline, which covers roughly 55% of the total classes that are taught.

Jim Dobson and Tim Heisler are on sabbatical for the 2018/19 academic year. Currently, their sabbatical project is hosting the 2019 Phi Rho Pi National Forensics Tournament in Reno, Nevada and developing online courses that will be offered in Fall 2019. Natalie Kellner is the temporary full time hire who is overseeing the department for the 2018/19 academic year. Her hire was due to the two faculty on sabbatical and Janet Brehe's retirement that occurred in Spring 2018. Due to her retirement, a new full

time faculty member is needed in 2018/2019 to continue the status quo of the CMST department.

In the **course success** measurement we observed a 3% increase in Withdrawal (W) rates for the 2017/18 academic year. Although it seems minimal, throughout the last five years the rate has barely increased or decreased by 1%. Looking a little deeper into the data, we noticed the fall 2017 semester holds a majority of the deficit. **The course success rates graph** indicates a 6% increase in (W) rates compared the past fall. The increase in withdrawn students leads to a 6% decrease in student success, which is drastically lower than the past five fall semesters, which traditionally fluctuates between 1%. The largest demographic of students effected by the (W) rate were Latino and White students. So what is up with Fall? We will review data in next year’s program review to see if we are seeing a trend.

G. Obstacles: What obstacles has your program faced in achieving plans and goals?

1. Our Forensics program still experiences the same needs identified in all of our previous program reviews. We continue to experience shortages in staffing and finances. After participating in eleven tournaments, winning 84 awards, and competed with students from colleges and universities across the nation we still have not received a budget increase for the 2018/2019 season. It seems to make no difference that we continue to identify this need in our Program Reviews when monetary support remains stagnant or, as was the case last year, is reduced.
2. We need to promote our Oral Interpretation and Readers Theater classes. Even though the CMST 2A class is a requirement for our AA and AA-T degrees it has been cancelled by administration due to low enrollment. We need to either promote these classes better to ensure that they fill or reevaluate

offering them on their current semesterly cycle.

3. Visual Aids. Travelling with printed visual aids on 30" x 24" poster board is an outdated mode of public presentation. For the betterment of our competitive program, and to improve our instructional quality in the classroom, We need to identify and incorporate newer, better, more "portable" technologies within our instructional and competitive repertoire.

4. We are still in need of a Forensics Assistant. We used to have this position. It was taken away from us during the massive budget cuts that took place 10 years ago. We have been asking to get it back every year since then. We are always denied the request.

5. We need to recruit more CMST majors. We are doing so by offering more of the degree specific courses that have high enrollments. This fall we offered CMST 3. In 2019 we plan to offer CMST 4 Introduction to Communication Studies.

6. Distance Education. We need additional course sections for the 2018/2019 academic year to develop and offer distance education courses that align with the Online Education Initiative (OEI) guidelines and standards. In order for the CMST division to stay up to date with the demands we would like to offer CMST 10 and CMST 11 as fully online courses by Fall 2019 so we can be OEI certified by Spring of 2020. Currently we do not have any online courses offered.

7. We want CMST faculty to be compensated as the primary instructor for co-instructing with the ESL/CMST collaboration.

8. We still do not have an instructional assistant for the Speech Program. This position became vacant back in 2007. We have been asking to have this position replaced every year since then. IT IS STILL A POSITION ON THE ARTS & HUMMANITIES ORGANIZATIONAL CHART. We are told every year to identify our needs and obstacles in our Program Review and Program Review Updates. We do so diligently. Each year our request for filling this position, this REPLACEMENT position, is rejected. This is not a growth position, we simply want to HAVE WHAT WE USED TO HAVE. We are now entering our 11th year without this position and it creates a tremendous hardship (both instructionally and fiscally) on the Forensics Program's ability to maintain their success (let alone enable the program to grow). You can imagine our frustration.

1. Have CMST faculty instruct collaborative workshop courses with the ESL program to help the

advanced ESL students with their public speaking development.

2. Growth and expansion of the forensics operating budget. We would like to see a reinstatement of our \$6400 yearly budget that comes from district funding. This amount was entirely cut several years ago, a portion of it was given back two years ago, and then that amount was reduced again last year. We are not even asking for growth. We just want to get back WHAT WE USED TO HAVE. We would like to see a reinstatement of our \$19,400 yearly budget that comes from co-curricular accounts. This amount was reduced to \$15,300 at the height of the budget crisis. We are not even asking for growth. We just want to have back WHAT WE USED TO HAVE.

3. We want to find ways to involve the community in our local speech tournament as judges, sponsors, contributors, etc.

4. We want to hire an instructional teaching assistant for the Communication Studies program.

5. We want to assist the LRC in choosing databases that specifically help our student population (Extemporaneous Speaking and the CMST 46 class).

6. We want to assist with LRC staff with the *Topic Selection* web page.

7. We want to host a high school speech tournament.

8. We want the Forensics team to travel and compete nationally.

9. We want the Forensics team to travel and compete internationally.

10. Revise Student Learning Outcomes for multiple CMST courses.

11. We want to offer CMST courses online by Fall 2019.

12. We need to hire a Forensics co-coordinator replacement for Janet Brehe since she retired this Spring 2018. We need a replacement full- time hire to begin Fall 2019.

The Communication Studies program serves to fulfill the college's Educational Master Plan in several ways:

The CMST program has encouraged **educational excellence** by:

- Assisting a segment of our population with their **work force readiness** on a yearly basis; we have students who enroll in classes not to obtain a degree but to enhance their public speaking and interpersonal communication skills for their personal use in politics, business, charitable organizations and religious genres.
- Developing and planning to offer OEI certified CMST courses online. Through these course offerings we are **creating accessible class schedules and supportive services** for nontraditional students.
- Planning for the Forensics team to travel nationally and international to tournaments. The travel requests **provide student opportunities to be informed, ethical, and engaged** regarding civic discourse. By traveling to tournaments on a national and international circuit, students will receive feedback on their performances from faculty and professionals throughout the United States, which will directly expose them to a diverse range of perspectives that may differ between state and international borders. As a result, student will consider feedback from diverse audiences and modify their performance to create programs that are ever evolving further encouraging innovation in their studies.
- In the future (long term 3-5 year plan), the development of a Communication Studies Lab will offer **educational support services** to LPC CMST students. The CMST Lab will offer learning support by expanding tutoring services on campus, **assisting underprepared students and addressing the needs of a basic skilled student.**
- In the future (long term 3-5 year plan) we would like to develop curriculum for a CMST 11 Intercultural Communication abroad course so we may update our **program to serve workforce needs**. Currently, over half of American employees placed abroad in international careers fail and return before their contracts are complete due to their inability to adapt their communication patterns to cultures unlike their own. This course will improve student's intercultural competence due to the opportunity to experiences diverse cultures first hand. As a result, they will apply their skills in future international careers.

The CMST Department has encouraged **community collaboration** by:

- Building a relationship with the ESL program to help the advanced ESL students with their

public speaking development. This collaboration ensures **excellence in student learning by collaborating with community partners to provide educational opportunities that best serve the needs of our students**. We do this by advancing student's communication competence and to develop a mastery of the English language.

As a discipline, we will continue monitoring this closely to see if this “trend” is corollary or associative. If we find that large classes consistently perform more poorly than small classes we will need to find ways to reduce the cap of our CMST 1 courses or incorporate a CMST focused laboratory for students to receive tutoring.
What changes in student achievement are evident across the semesters you analyzed? What

<p>are some possible explanations for these changes?</p> <p>CMST 1 is a performance-oriented class with students delivering multiple speeches each semester. Because high enrollment classes require so many presentations there is less time devoted to lecture and speech preparation. This became particularly evident with the 5-week Summer section. Simply put, it is difficult to cover the required course content with large classes.</p>
<p>DO you plan to continue tracking this SLO in the next year? Explain.</p> <p>Yes, we will continue analyzing faculty SLO results from CMST 1 to continue assessing student performances as the classroom cap size remains at 30.</p>
