#### 7. eLumen/Assessment Schedule

IT was discussed that currently we are in data overload and not getting to the importance of closing the loop and best practices. On the other hand, data is required to meet the accreditation standards. It was debated whether to change program review so that PSLOs are only reviewed in year 4 and year 7 before accreditation reports. PSLOs would not be part of the programs reviews in between. Faculty would still need to assess and put in data. This would give faculty flexibility to decide what they want to look out that is important to their department. The possibility of GE PSLOs, were discussed as a starting point for review as it would lead to more useful data. Ann Hight is going to meet with Karen Spirn to discuss the program review piece further. Committee liked these ideas, but was concerned that by not having PSLOs in Program Review every year, faculty may forget to enter data into eLumen. It was discussed also whether SLOs approved this semester should be entered into eLumen effective Spring 2019 to allow for data entry for accreditation, however the SLOs on the syllabi would no longer match. This will require further discussion.
