4. Accreditation Report

John Ruys had a scheduling conflict so Ann Hight will speak on his behalf. The next step is the disaggregation of data, as required by accreditation to compare student populations. John Ruys suggested first to disaggregate Face to Face from Distance Education courses. The committee thought that it would also be good to separate out hybrid courses.

He would like input on what to specifically discuss. The committee reviewed the Institutional Statistics report from eLumen. When we submitted our midterm accreditation report the number of CSLOs assessed was much higher, because we pushed faculty to enter data and, which we will no longer do, counted courses in families and cross-listed courses as one. It was discussed that John Ruys should discuss that SLO Coordinators must be looking at the reports in eLumen and what the expectations are for faculty. Madeline Wiest will send all of the coordinators the Faculty Participation Report in eLumen as an example.

8. SLO/SAO Liaison Report

Mike Schwarz stated that SAO's can now be entered into eLumen, previously there was a glitch in the system. He sent Madeline Wiest all of the SAO Coordinator updates for Fall 2018, including tutoring moving to SLPC division. The goal is to get all of the student services areas to have at least one SLO fully assessed and close the loop by Spring 2019. Angelo Bummer stated that he has been working on SLOs and PSLOs with several groups including Dance and Fire Service Technology.

- i. Automotive Technology

- ii. Business
 - **CSLOs-** 1.) Upon successful completion of this course, students will be able to identify and categorize the financial statement elements associated with the balance sheet and income statement.

- **CSLOs Returned for Revision-** Clarify “this course” with course title
- iii. ENGR 44: Introduction to Circuit Analysis
 - **CSLOs-** 1.) Upon completion of ENGR 44, the student should be able to analyze a 2nd-order RLC electrical circuit, for both natural and forced response
 - **CSLOs Returned for Revision-** Needs period at the end of sentence
- iv. Engineering
 - **CSLOs-** 1.) Analyze circuits with magnetically coupled inductors 2.) Define Materials Science terms by matching descriptions
 - **CSLO Returned for Revision-** Need standard wording “Upon completion of...” and period at the end of the sentence.
- v. FST 1: Fire Protection Organization
 - **CSLOs-** 1.) Upon completion of FST 1 Fire Protection Organization, the student will be able to illustrate the history of fire service.
 - **CSLOs Returned for Revision -** Remove course title from CSLO, as it not part of standard language.
- vi. MUS 37: Music Industry Career Development
 - **CSLOs-** 1.) Upon completion of MUS 37, students will be able to distinguish and analyze a variety of music industry career pathways. 2.) Upon completion of MUS 37, students will have the tools necessary for marketing and promoting musical events, ensembles, and companies. 3.) Upon completion of MUS 37, students will conduct and present research on trends and strategies within the music industry.
