V. Officer Reports

A. ICC Chairperson

Ms. About reported that she is working with the Medical Association and helping them. She also reported that she is working on a Facility Request for She also stated that she attended some club meetings. She stated that GSA is a good example of an organized meeting.

C. ICC Treasurer

Mr. Koth reported as of September 30, 2011 the ICC account balance is \$9989.16.

D. AS President

Mr. Salehzadeh reported that there is an increased interest in new clubs on campus. He stated that clubs are doing a great job on their events, and he mentioned that Physics/Astronomy Club is a very active club. He announced that the student activity fee went from \$5 to \$10 and explained that the students will benefit from the increase.

VIII. Club Reports

FACE: Informed the ICC that it is Disabilities Awareness Month. Ms. Abercrombie stated that she will be sharing her testimony about seizures on October 26 in the café from 12:15 p.m. - 1:15 p.m.

Danzan Ryu Jujitsu: Announced that there will be a Martial Arts Seminar in the gym on December 10 from 12 p.m. - 5 p.m. The cost for entrance is \$20.

Old Business

A. Club Activation/ Deactivation

Ms. Aboud reminded the ICC that Finance Club was proposed at the last meeting. Biology Club had representatives share information about the goals for the club during this meeting. Ms. Saleh and Ms. Groth informed the ICC that Biology Club will provide students with opportunities in Bio Technology, volunteer positions, and beneficial field trips. The club's main focus will be research, and it may become an honor society called Tri Beta Biology Honor Society. The ICC will be voting on activation for both the Finance Club and Biology Club at the next meeting.

A. Honoring Club Achievements

Ms. Abercrombie expressed her passion about celebrating clubs that have improved the campus. She suggested that deactivated clubs should have a historical medal. Ms. Aboud stated that there are awards for ICC members at the end of the year. A consensus was taken and the ICC was in favor of honoring past clubs. Ms. Aboud indicated we should look into this.

B. ICC Dodge Ball

The dodge ball event will take place Friday October 28 from 9:30 a.m. - 11:30 p.m. Ms. Aboud stated that each team must have a minimum of 8 members. Clubs can team up to meet the minimum team requirement but cannot exceed 10 team members and can only combine with one other club. There will be money prizes to add to the winning club's funds. These prizes will be: \$100 for first place winner of the tournaments, \$75 for second place, \$50 for third place, \$25 to the best dressed club, and \$25 for the most enthusiastic losing club. Ms. Ross suggested that the best dressed prize can go to first, second, and third place winners, but the prize money for the most enthusiastic loser cannot. The ICC agreed with her suggestions. If a team that teams up with another club wins a prize the teams must split the prize money evenly.
