PREPARING FOR COLLEGE REOPENING

The Office of the Vice President of Student Services at Las Positas College is taking proactive steps to prepare for the reopening of the college to employees, students, and the greater community. Thus far, we have purchased personal protection equipment (PPE) to include cleansing wipes, face masks, face shields, gloves, and sanitizers. We have also worked with Maintenance & Operations (M&O) to install plastic barriers at service counters and windows. We have also ordered floor stickers to help with social distancing, we have purchased stanchions to help better coordinate student lines, and we are exploring a new electronic queuing system. Campus Safety & Security is exploring new road and campus signage to inform every one of the requirement to wear face masks, adhere to social distancing, and remind those who are sick to stay home.

THE MARKET UPDATE

Las Positas College resumed hosting The Market on Tuesday, May 19, 2020 with the support of the Student Life Office, Campus Safety & Security, Student Health & Wellness Center, and Maintenance & Operations (M&O). EMPLOYEE TUBERCULOSIS TESTING

Las Positas College employees that require Tuberculosis (TB) testing for continued employment with the Chabot-Las Positas Community College District (CLPCCD) may opt to be tested by the Las Positas College Student Health & Wellness Center. Stanford Health Care - ValleyCare, the entity that administers our Student Health & Wellness Center, is willing to perform TB testing per established guidelines and health protocol. DREAMER RESOURCE LIAISON

Catherine Alfaro Gomez, Financial Aid Outreach Specialist, has agreed to serve as our college's first Dreamer Resource Liaison beginning in the 2020-2021 Academic Year. In her role as Dreamer Resource Liaison, Catherine will serve as a resource for undocumented students and will assist and refer students for financial aid, social services, state-funded immigration legal services, internships, externships, and academic opportunities. The designation of a Dreamer Resource Liaison is an unfunded state mandate that means the college is not going to receive any additional funds to comply with the new state law. While Las Positas College does not currently have physical space available to serve as a Dream Resource Center, we remain hopeful that a future Student Center facility may accommodate such an important venue. Thank you to Catherine for accepting this important and vital responsibility to serve our undocumented students.
