The lab will offer enhanced instruction and support associated with the course content:

- A. Critical Reading
 - 1. Enhanced instruction in summary writing:
 - a. Support students in identifying main ideas and support points of complex nonfiction texts.
 - a. Enhanced instruction by providing reading strategies to recognize main points and to differentiate from supporting details
 - b. Expanded navigation of complex vocabulary
 - b. Enhanced instruction in understanding the practice of paraphrasing an author's ideas and maintaining neutrality, avoiding analysis, and avoiding wording and sentence structure of the original
 - a. Additional practice rewording an idea without copying wording or sentence structure.
 - b. Further practice associated with importance of avoiding personal opinion
 - c. More instruction with tagging ideas with reporting verbs to practice identifying ideas that are not the student's own.
 - c. Enhanced negotiation of difference between 1) individual student's interpretation of text's main ideas and meaning and 2) main ideas and meaning that writer most likely intended
 - a. More work helping students avoid "fast pass matching," where students relate an author's statements to something they already believe and misrepresent the author's idea.
