The **21-22** Compliance Exam will be **available Thursday, July 15 at 11 am**. It is new and improved as it works in all browsers and allows you to stop the exam and return to it among other new features. The link is <https://exams.ccaasports.org/>.

Everyone must pass the exam with a score of at least 80%, including the Reward Exam. Athletic Directors, please be mindful of the emails that you receive as they will indicate whether the

individual passed or failed in the subject line, the exam taken and the score. Please be sure to follow up accordingly if someone failed or took the wrong exam for their position. The emails should be more reliable but if not, once you login to the system you have a reports tab where you can pull up an A to Z list. **Please note that the email only sends if the examinee scores 100% on their first attempt or takes advantage of the Second Chance option.**

Please be sure to read the attached documents. One has tips for the R-1, R-2 and the Compliance Exam and the other has directions for the exam, which are also on the Compliance Exam website under Membership Services. The directions are posted on the exam website and within the exam.

The **21-22** version of the Constitution & Bylaws has been posted on the Constitution page under Membership Services and is also available as a link within the new exam system. Additionally, all Constitution & Bylaws forms **were** updated to the **21-22** versions **a few months ago**. As always, I caution printing multiple copies of the C & B for the first month or so as it's inevitable that there are a minor few changes to be made.

Those individuals who scored at least 90% on a full exam in **19-20** will be given the Reward Exam once they login provided they use the same login that passed the exam and hold the same position (take the same exam). Users will be prompted to verify their position and other information before proceeding to the exam itself. There is a demo exam available for those that would like to see how the system works.
