### B. <u>Approval of February, 2016 Minutes</u>

Jim Meehan moves to approve the minutes of February 11, 2016 Mike McQuiston seconds the motion Approved by the majority with Nan Ho and Mike McQuiston abstaining

• **Mark Tarte** – Advisory important to keep program current and relevant; also helps with decision making

## D. Faculty Report – Mark Tarte

- Numbers are up from last year, but down from last 10 years
  - Combination of the Ferguson Effect and hot economy (when the economy is bad numbers go up, but funding goes down)
- Accrediting Commission for Community and Junior Colleges (ACCJC) coming in March/April, 2017
  - SLO and others currently in progress
  - School may use a different accreditation agency
- Adjuncts meet in May
- New eLumen system to document student learning outcomes change or improve things; Blackboard going away, Canvas will take its place
- ADT state does not require report writing for CSU
- Summer Session, 2016, 10 enrolled students; probably will not be a summer session in the future; intro course this past summer; first summer in fourteen years.
- Public Safety Majors fair this past fall and this spring
- Veterans VA wants personal information about Veteran students to make sure they are seeking education and employment (because of past problems with for-profit schools)
  - Alameda County has 143 instructors according to POST standards some instructors are "as needed"
  - May become an Academy for Veterans
  - VA wants to know if instructors are part of the college system
  - May use G.I. bill for education funds
  - VA wants college credit for education
- AJ Certificate of Achievement approved
  - Will help track number of students who complete the Basic Academy
  - Will take the state 4 to 6 months to approve
- ROP Justice Academy for high school Juniors and Seniors starts at LPC in the Fall of 2017. Two hours, 8:00 9:50 in Room 2206. Students will be in uniform. POST recommends program for outreach to combat background failure; 35 to 70- students per year
- New course AJ88, Police and Hollywood, a historical look at media's influence on AJ
- Nan Ho Summer AJ class classes at high schools in Pleasanton and Dublin in a rented space or at the high school, fall or spring, afternoon/evening; pilot in the Spring at district with G.E. classes
- Mark Tarte retiring Summer of 2018
- Bond Measure A, \$950M using the 2012 master plan
  - Public Safety building for Fire, AJ and Paramedic/EMT
  - LPC is receiving 40% of the bond
  - Modular Academy one time a year under the auspices of the RTC
  - CTE (welding, auto, viticulture/enology, Public Safety) in one building; majors not interchangeable, uses too different; want Advisory's opinion on the facility

#### Discussion

- Jack Tucker Terrible idea law enforcement hands on with fake guns, yelling, police dogs; POST standards mandate separate facilities
  - No fire arms training
  - Alameda County Fire has approached Alameda County Sheriff's office because the Fire Department may lose their lease in San Leandro
  - Alameda County Sheriff's Office has 8-9 acres in between the animal control and Scenario Village, Alameda County Fire proposed community college facility with Alameda County Sheriff's office may be in the works
  - Orange County model large, nice training center owned by the community college, but run by Orange County, LAPD and LASO; Orange County runs night AJ classes
  - Alameda County Fire Academy not affiliated with the college. Run one academy a year with 25 students
  - Need to make sure LPC and Chabot are complimenting instruction and not competing
- Mike McQuiston not a good idea to have all CTE in one facility; Michael Norton facility needs to be separate because of safety

## E. <u>Public Safety Manager Position</u>

- Will work with the three Public Safety Majors
- Curriculum development, marketing, recruitment
- Timetable, January, 2017 plan submitted to state
- \$103K to \$112K to start
- Running Public Safety is a full time job needs to be its own director
- Need Advisory's help to convince district
- Motion to move forward within the parameters of the grant by Jim Meehan, seconded by Mike McQuiston and approved by unanimous vote

### Discussion

• Mark Tarte – 20% of time spent marketing to high schools; numbers were good, but have gone down with the improvement of the economy

## F. Industry Update

- Jack Tucker ACSO graduated academy with 24 students, which was a financial burden on the Sheriff's Office. December of 2016 has 65 students; ACSO may only run two academies this year (LaVaughn Hart is aware of this issue)
- LPC is flexible with the number of academies
- Mike McQuiston Alameda County Chiefs of Police are also having trouble recruiting, over 350 candidates and no hires; Sunnyvale has been recruiting in HI because there is a large military presence there and probably less drug use
- Mark Tarte Issue of legalizing marijuana
  - Jack Tucker cannot use schedule 1 drugs, grounds for dismissal

## G. <u>New Technology – Mark Tarte</u>

• Task Force with maintenance to install new, more secure locks, electronic clocks and window coverings for active shooter

- Can ACSO use LPC facility for Urban Shield September 7-11, 2017?
   Ask Sean Prater and Diane Brady
- Mark Tarte wrote letter to the editor of the LPC paper regarding Urban Shield
- Jim Meehan Marketing to increase enrollment
- Mark Tarte need to be invited to high schools outside the district
- Vicki Shipman 48 LPC students from Mountain House, Delta College will allow LPC to recruit in Tracy
- Mark Tarte Stockton traditionally trained their police force at Delta College in an extended academy
