#### Recommendation

Based on all available data, there appears to be an "undersupply" of Heavy Truck Driving workers compared to the demand for this cluster of occupations in the Bay region and in the East Bay sub-region (Alameda and Contra Costa counties). There is a projected annual gap of about 3,596 students in the Bay region and 1,431 students in the East Bay Sub-Region.

#### Introduction

This report provides student outcomes data on employment and earnings for TOP 0947.50 - Truck and Bus Driving programs in the state and region. It is recommended that these data be reviewed to better understand how outcomes for students taking courses on this TOP code compare to potentially similar programs at colleges in the state and region, as well as to outcomes across all CTE programs at Las Positas College and in the region.

This report profiles Heavy Truck Driving Occupations in the 12 county Bay region and in the East Bay sub-region for a proposed new Reddaway Truck Driving Apprenticeship program at Las Positas College.

In the East Bay Sub-Region, there is also a gap with 1,431 annual openings and no annual (3-year average) awards for an annual undersupply of 1,431 students.
