4. 3/19/21 Special PBC Mtg. Debrief

- The VC of Business Services proposed a new BAM model
- The revenue only model showed LPC at 40.27 and Chabot at 59.73

Budget Development Committee

- If implemented this year, it is a loss of 1.33 million for LPC
- The committee the lack of data did not provide a base to work from
- The model may promote unbalanced work and equity issues
- The committee discussed penalties for expenditure over spending and how to right size it
- The financial tenets LPC historically follows go unnoticed
- CARES is now known as the American Recovery Act
- LPC received 10 million dollars; it is split between Student and Institution portions
- LPC charged the full 47% of Federal indirect cost against the received
- Movement of the money to the unrestricted general fund is allowable
- VC of Business Service stated the money stays with LPC to budget against the ending fund balance and pay for overages back to the District
- It is allowable to use the money to cover lost revenue
- LPC was over by 1.3 million this year
- A question posed, will the District ask for pay back from the unrestricted general fund that was generated from the indirect cost savings
- There is room for negotiation as the proposed BAM is not final
- The committee suggested adding, meeting accreditation standards to the guiding principles
- District level conversations included allocation based on how money is received from the State which may lead to conflict between the Colleges
- Replication of the State model provides colleges with a base allocation in addition to the SCFF
- 98% of budget goes to salaries and benefit; right size is 85-87%
- Proposal of onboarding the frozen positions brings LPC back to almost 100%
- Points of context are the 2% raises this summer, 1.5% step in column adjustments, and possible increased COLA in the May revise
