# 4. Review Adopted Budget

- The Chancellor's Office extended the deadline to October 1
- Personnel continues as the biggest budget allocation
- District manages position control and includes benefit costs
- Ideally the goal is to make no changes the tentative budget
- Discretionary (four thousand) accounts over ten-thousand dollars were the only ones to receive a 5% cut
- There were not cuts to salaries
- Travel, conferences, overtime, student assistants, and supplies accounts were cut
- Divisions can view their budget the next morning after the October Board meeting

# 6. Review Expenditure Analysis

- The committee reviewed the expenditure spreadsheet received at the PBC meeting
- The percentage of salaries in the most recent year is 97.08 which does not include the 2% increase
- The committee felt contract services might require assigning the cost under personnel and not services/discretionary
- A system of checks and balances is the best way to manage position control and ensure funds are available
- Overspending is seen across the board at the District, Chabot and LPC
- There are some discrepancies on the expenditure spreadsheet
- In 4, 5, and 6, there is 1,034,760
- In the 1 and 2 there are part timers without a position control number
- 4000 are supplies at \$192,353.00
- 5000 are services
- 6000 are capital outlay

- In 2011, 4,5, and 6 were at 1.2 million
- Additional money was not given to the colleges to cover the salary increases
- The opportunity to move to a new BAM should take place after the current position control issues are fixed.
