 - BIO (formerly BIOL) 5, 10, 20, 31, 50 will stay with the same numbers.
 - ECOL 10, finally, will become some number like BIO 15 or 60.

Discussion: A matrix is to be created by faculty to show changes and course numbering. Also there is to be a note in the 2014-16 catalog that states effective Fall 2015 all biological sciences will be listed under one heading.
