## 7.1. <u>CIP Code</u> transition

- > Effective Fall 2027, state will not be using TOP codes
- > TOP Code Crosswalk shows TOP associated with CIP code
- Faculty will need to enter CIP when submitting curriculum in Meta
- Deans will be working with faculty for CIPC/TOP categorization
- 7.2. Independent Study courses sunsetting, course review
  - CK: is it okay to remove Independent Study courses removed from sunsetting policy? Independent Study is not necessarily Curriculum that needs to be

- reviewed because they are written differently and generally. Curr. Committee approves.
- CK: is it okay to remove Independent Study courses from the course review cycle? (same reasoning as removing from sunsetting policy)
- CK will amend both policies stating Independent Study courses are not included- will add "Independent Study Courses are not subject to this policy"; Curr. Committee agrees with change.

## 7.3. Cross-listing of courses

- Question of why are courses cross-listed? For example, future CCN of SOCI courses will present issue of SOC 3 being cross-listed with ETHS 6 at LPC.
- CK proposal: deactivate SOC courses of ethnic studies, keep ETHS versions because it will help with CCN changes that might be implemented in the future.
- ➤ MV: The reason some courses were cross-listed For example, KIN 1/NTRN 5 Sports Nutrition was cross-listed to increase enrollment from KIN students. KIN students might not look for NTRN, but with a KIN prefix it would attract Kinesiology students.
- Further discussion with faculty regarding cross-listing and clarification for need.
