If an impeachment proceeds, the Senate will also be asked to vote on the removal of the officer from the 2025-2026 LPCSG cohort.</p> <p>Article XIII Section 2: Impeachment The LPCSG Advisor, President, and/or Designee is responsible for overseeing the impeachment process.</p> <p>A. Any officer shall be eligible for impeachment by the LPCSG Senate as soon as two (2) violations have been committed.</p> <p>B. Upon an officer’s first instance of a violation, the officer will receive a letter of warning documenting the violation and presenting a plan to proceed.</p> <p>C. The articles of impeachment will be added to the agenda of the next regularly scheduled Senate meeting and presented by the Chair or designee.</p> <p>E. The LPCSG Senate shall preside over all impeachment hearings.</p> <p>F. An Officer shall be impeached by a two-thirds (2/3) majority vote.</p> <p>G. If the impeachment does not proceed, the officer cannot be impeached for the same instances of a violation.</p> <p>H. After an Officer is impeached, the LPCSG Senate shall have the power to remove said Officer through a two-thirds (2/3) majority vote.</p> <p>I.
