5.1. SLO Chair Report

- Due to Title 5 changes, SLO Committee is not reviewing SLOs; the workflow in Meta is no longer there. SLO modifications must be submitted as a course modification and approved/reviewed through Curriculum Committee.
- CSLOs need to be mapped to PSLOs – Program Area Coordinators will be able to edit this tab in Meta without triggering a course modification. The Curriculum Chair confirmed the Curriculum Committee does not need to look at CSLO to PSLO mapping. Program Coordinators will need to be reminded and prompted to manually go into individual courses and map CSLOs to PSLOs.

7.1. Midterm Accreditation Report

Rajinder Samra

- JR: RS is here to provide insight from the Accreditation Steering Committee. SLO Committee is looking for further clarification as SLO Comm. does not look at data specifically. The Program Review Committee reads more of the data with the program review cycle.

- RS: The Midterm Report occurs 4-years after the site visit, which was in 2022. The Midterm Report is due in 2026 for LPC. The Midterm Report's purpose is for accountability, transparency, and that the institution is following through on accreditation standards set; as well as, a reflection regarding data and student learning.
- JR: SLO Comm. does not necessarily read/analyze any data. The Program Committee reviews the outcomes that are assessed and will do their program review annually. SLO Comm. can rather contribute to why we transitioned from eLumen to Meta and the improvements since. For example, Meta will provide a disaggregated report that can be at course-level and program-level. Additionally, SLOs were never able to be archived or stored in one database, including the assessed data. Meta allows for a singular database storing both data and assessment of data by faculty that will be better accounted for.
- JR will draft a summary of improvements made within and by SLO Committee to be further reviewed by the Accreditation Steering Committee to contribute to the Midterm Report.

7.2. Flex Day Workshop
